1. **USE OF A MAXIMUM OF \$900,000 IN LOW AND MODERATE INCOME HOUSING FUNDS FOR THE NORTH SHAFTER WASTEWATER PROJECT:** a request to approve Resolution 135-10 authorizing use of a maximum of \$900,000 in low/moderate income housing funds to supplement the North Shafter Wastewater construction project (\$500,000 grant); and to fund loans to North Shafter residents for physical connection to sewer truck lines and demolition of existing septic systems and leach fields (\$400,000 loan).
