



# Shafter First Fridays Street Fair Booth Application

Thank you for your interest in the Shafter First Fridays Street Fair. The City of Shafter hopes that First Fridays Street Fair will begin to be a well-loved annual event for the entire community and a boost for our downtown businesses.

### Booth Space (approximate 10' x 10')

- Downtown Business – NO FEE
- All others - \$50

**Food Booth Application Deadline – May 19, 2023**  
**Non-Food Booth Application Deadline – May 19, 2023**

**ALL vendors must provide the following no later than the above-mentioned date:**

- Booth Application and Liability Waiver
- Temporary Food Facility Certificate – Public Health Certificate (food booths only)
- General Liability Insurance Policy of \$1,000,000 per occurrence and General Aggregate limit of \$2,000,000.
- An Endorsement identifying the “*City of Shafter, it’s Officers, Employees, City Council Members, Agents, Boards and Commissions*” to be added as an additional insured with coverage at least as broad as ISO form CG 20 10.
- Policy must identify the following as a Certificate Holder, specifically listed as: City of Shafter, 336 Pacific Avenue, Shafter CA, 93263

If you do not have liability insurance for a business, it is also possible to purchase insurance for this event from the City of Shafter:

Fees for Certificate of Liability from the City of Shafter	
Exhibitors (No Sales)	\$46 - Per Day/Per Exhibitor
Concessionaires (Non-Food Sales)	\$86 - Per Day/Per Concessionaire
Concessionaires (Food Sales)	\$79 - Per Day/Per Concessionaire

\*Additional application is required if purchasing insurance from the City of Shafter

### FOOD BOOTH APPLICANTS:

**Kern County Health regulations must be followed by all food booth vendors as explained in the Kern County Environmental Health Permit Packet. If you have any questions, you may contact the Environmental Health Services Department at (661) 862-8740.** Food Booth structures and equipment will be the sole responsibility of the applicant and must conform to the Kern County Environmental Health Department standards. If the food booth guidelines are not followed, the health inspector has the authority to close your booth. BOOTH SETUP will start at 1:00 p.m. on the day of the event. ALL VEHICLES are to be removed from the street by 3:30 p.m. for safety reasons. **THIS RULE WILL BE STRICTLY ENFORCED.** Booth spaces will be marked and a map will be available at the City Registration Booth. ALL BOOTH VENDORS MUST STAY until 9 pm unless cleared by a City Official.
